

There are a number of errors assigned, but as there is no bill of exceptions in the record there is but little left for us to review. The numerous motions made by the defendant during the progress of the case, the objections made at the trial, the instructions offered and refused, and the motion for new trial, are saved in the record by proper bill of exceptions, and present no questions for our consideration. The defendant demurred to the indictment at the proper time for the reasons: 1. That the grand jury which found the indictment had no legal authority or jurisdiction to inquire into the offense charged for the reason that said grand jury was not selected, formed and empaneled as provided by law. 2. That the indictment does not state facts sufficient to constitute a public offense. This demurrer was overruled and defendant excepted. The first cause assigned is not a proper subject for demurrer under criminal procedure act of this territory. The demurrer searches the indictment itself and points out defects apparent on its face. It is not a proper requisite of an indictment that it state or disclose the manner in which the grand jurors were selected or empaneled. The second cause of demurrer tests the sufficiency of the facts pleaded to constitute a...
